	<u>ADVANCED OBEDIENCE (On and Off Leash)</u> The following cues will be taught:

<i>Owner Initials</i>	All cues are taught <u>1</u> time(s) per week for <u>6</u> week(s) and the Owner is required to work the dog(s) 7 to 12 times a week on strengthening all cues taught. The reinforcement can be accomplished in approximately 20 to 30 minutes per day per dog.
	<u>AGGRESSIVE BEHAVIOR</u> By placing my initials in the box next to this paragraph, I acknowledge the Company has determined that my dog(s) may be aggressive or is aggressive. The Company has fully explained that since the outcome of any training service program cannot be guaranteed and the aggressive behavior on the part of my dog(s) is or may become a risk to people and/or dogs, my decision to enroll in a training service program is done solely and completely at my discretion with me taking 100% responsibility for any damage my dog(s) might cause to anybody or anything during or after the training service program. I further agree to take all possible safety measures recommended by the Company, including, but not limited to, muzzling and leashing my dog(s) when around other dogs and/or other people.

CANCELLATIONS

Additional make up training services may be purchased at \$65.00 per service.

TERMINATION OF SERVICES

The Owner may withdraw from the Company's services at any time, however, all pre-purchased sessions and fees are non-refundable once services begin.

LIABILITY

I, _____ as the Owner of the pet(s) named on the Group Class Client Agreement, having carefully read and fully understand this Addendum A, do hereby waive and release the Company from any and all liability of any nature. This includes any injury, death, sickness or damage my pet may suffer during or after any services rendered by the Company. I also agree to indemnify and hold harmless the Company from any and all claims due to damage my pet(s) may cause to any persons, places or things during or after training service.

The Owner specifically acknowledges the risk of taking a group class with other people and other dogs. This risk is entered into with the Owner 100% responsible for the behavior of the dog(s) at all times in and out of the class.
