CANCELLATIONS

The Owner may postpone any of the training services, free of charge, provided at least 24 hour notice is given to the Company. The Company will give 1 free make-up training service due to Owner postponements with a less than 24 hour notice. Provided the Owner has pre-purchased a block of training services, after the 1st postponement, each additional owner postponement with a less than 24 hour notice will count as one of the remaining training service(s) owed to the Owner. Additional make up training services may be purchased at \$65.00 per service. The Owner understands and agrees that failure to give the Company 24 hour notice of a training service cancellation will result in the Company counting said failure as a completed training service.

TERMINATION OF THE SERVICES

The Owner may withdraw from the Company's services at any time, however, all pre-purchased sessions and fees are non-refundable once services begin.

LIABILITY
